Sir / Madam,

1. In view of denial order issued by the Ministry of AYUSH, New Delhi /Central Government vide above cited letter dated 18/01/2021, your College has approached Hon'ble High Court for relief.

In light of the Hon'ble High Court Order referred at serial no. 4 above stating that the petitioner is hereby permitted to participate in the ongoing counselling process in the State of Maharashtra. This being an ad interim order, it is naturally subject to the results of the writ petition, and the petitioner is directed to inform prospective candidates accordingly alongwith Interim Order dated 15/04/2021 of the Hon'ble High Court, New Delhi referred at serial no. 4 above stating that Interim Orders to continue. The matter of Conditional Affiliation was placed before the Academic Council meeting held on 28/07/2021 & it has resolved to grant the conditional Continuation of Affiliation/Extension of Affiliation to the Homoeopathy (UG) B.H.M.S. course of your college is granted for the Academic Year 2020-21, subject to following conditions:

(a) Subject to final outcome in W.P. (C) 3542/2021 & CM APPL. 10711/2021 dated 17/03/2021 and 22/03/2021

(b) The intake capacity shall be 50

- The College shall submit Affidavit in the prescribed format as per Academic Council's Resolution No. 229/2013 (Format attached).
- Information of all College Teachers shall be updated on the University Academic Online Teachers Database & monthly review shall be taken by College Coordinator so as to ensure that teacher's information is regularly updated.
- In case students are admitted in your college, it shall be brought to their notice that their admission is subject to final outcome in W.P.(C) 3542/2021 with CM APPL. 10711/2021 dt. 17/03/2021 & 22/03/2021. Also inform students that their admissions are subject to both the referred Court Orders mentioned above. Also, take undertaking from the students as prescribed by Academic Department Circular No. 20/2021 dtd. 08/03/2021 and letter dtd. 12/02/2021 of Govt. of India, Ministry of AYUSH.
- Those UG/PG qualifications that are not yet recognized by the Central Govt. it is mandatory for the college to apply to the Central Council through Central Govt. and ensure that Permitted/Not Recognized qualifications are enlisted in "Recognized Qualifications", failing which University shall not grant Continuation of Affiliation to such courses from ensuing Academic Year & no student shall be admitted in such courses.

You are requested to comply with the above mentioned deficiencies within 3 months without fail and submit compliance report.

Important Note:

- 1) The Continuation / Extension of Affiliation is issued for the Academic Year 2020-2021 subject to the permission of Central Council of Homoeopathy, New Delhi/Govt. of India/Department of AYUSH, New Delhi and if the permission is declined by the said authorities this Continuation / Extension of Affiliation shall be treated as cancelled.
 - 2) The admission shall be done only through the Competent Authorities.
