I have come to the conclusion that, Tubectomy operation can be performed in this operation theatre under safe a hygenic condition. Hence the operation theatre of Homeopathy Medical College Akola hospital is approved for performing sterilisation operations on the following conditions.

1. Proper record of all the operated cases is maintained. Especially R-3 register is maintained up to date in prescribed format. All operated cases must be entered in R-3 register.

2. Proper cases are selected for sterilisation operation. Pre operative, operative and post operative preparation and treatment is done properly and datewise record maintained accordingly.

3. Operations are performed by qualified, competent, experienced and authorised doctors only.

4. Procedure of Fumigation, sterilisation of instruments, linen etc. anaesthesia, operative procedure and treatment etc. are followed strictly as per the guidelines issued by the Additional Director of Health Services, FW, MCH & SH, Pune from time to time.

5. Consent forms of operated cases are promptly and regularly submitted only to

(Civil Surgeon, General Hospital, Akola) Urban Health Centre Ashoknagar.

6. The amount of incentives etc. will be reimbursed by C.S. Akola.

7. All the concerned records should be made available for inspection at any time to the competent authorities.

8. Any untoward reaction should be informed to this office and concerned promptly.

9. Failure to comply above instructions, the centre is liable for derecognition.
