12. Ozone hospital will not be responsible for quality of training, education for the internship student.

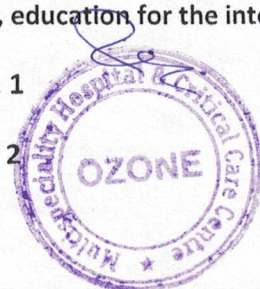

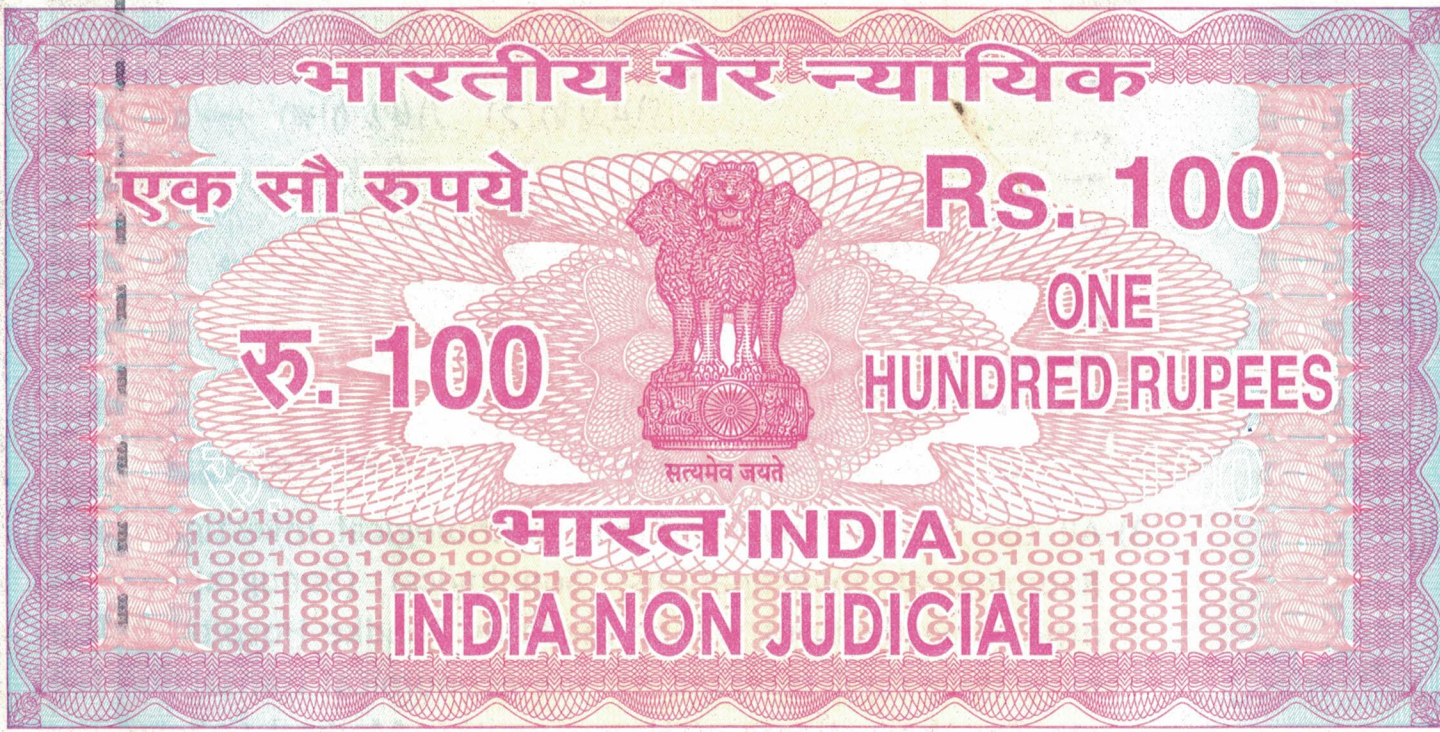
