

Sir,

This has reference to this Ministry's letter of even number dated 25th July, 2014, wherein amnesty for non-enforcement of HCC (MSR) Regulations, 2013 was granted for the academic year 2014-15 for all existing Homoeopathy Colleges due to the absence of enabling provision in the HCC Act, 1973 for granting permissions on annual basis to the existing colleges. Further, CCH was requested to inform all the existing Homoeopathy Medical Colleges and also direct the colleges to ensure compliance of HCC (MSR) Regulations, 2013 and accordingly remove all the shortcomings by 31st December, 2014 for getting permission for the subsequent academic session 2015-16 as per the provisions of HCC (MSR) Regulations, 2013.

2. However, as the enabling provision in the HCC Act, 1973 for granting permissions on annual basis to the existing colleges are still not yet incorporated in the said Act, the amnesty for non-enforcement of HCC (MSR) Regulations, 2013 is being granted for the academic year 2015-16 to all existing Homoeopathy Colleges. Accordingly, you are requested to inform all the existing Homoeopathy Medical Colleges.

Sub: - Grant of Permission for continuing admission in the year 2017-18 of the Homoeopathic Medical College, Akot Road, Akola-444001 (Maharashtra)- regd.

Sir,

I am directed to refer the provisions prescribed under sub regulation 3(4) of HCC(MSR), 2013, wherein, the existing college has to fulfill the minimum standard requirement of infrastructure, teaching & training facilities by 31.12.2014 for consideration of grant of permission for undertaking admission in the coming academic year. Further, as per the provision of sub regulation 3(9) of HCC(MSR), 2013, if the existing colleges fails to achieve full compliance of the requirements as specified in the regulation by 31.12.2014 the college may be stopped for taking admission in existing Courses.

2. In order to verify the compliance of the College, CCH has conducted the inspection of Homoeopathic Medical College, Akot Road, Akola on 22.07.2017 and furnished the report of inspection of CCH to the Ministry for further consideration in the matter of granting permission for the A.Y. 2017-18.

3. After considering the provisions of HCC(MSR) Regulations, 2013, inspection report of CCH and policy of the Central Government for granting conditional permission during the session 2017-18, permission of the Central Government is hereby granted to Homoeopathic Medical College, Akot Road, Akola for continuing admissions in BHMS course with fifty (50) seats for the academic session 2017-18 subject to condition that the college shall fulfill the following requirements by 31st December, 2017 which will be verified for granting permission from the academic session 2018-19: -

- i. all the Minimum Standard Requirements of infrastructure and teaching & training facilities as specified in Regulation 3 of the "Homoeopathy Central Council (Minimum Standards Requirement of Homoeopathic Colleges and attached Hospitals) Regulations 2013" by 31st December 2017 to get permission for a period not exceeding five years. Failing which, all the

existing colleges, which are not able to achieve full compliance of the requirement as specified in these regulations by the 31st December, 2017, shall be denied permission from academic year 2018-19 onwards and action as envisaged under section 19 of the Act shall be initiated against all such colleges apart from rejection of their applications under sections 12A, which have been under consideration by way of conditional permissions or denials"; and

ii. all the requirements under the provisions of the HCC Act, 1973 and relevant Regulations made thereunder should be fulfilled *in toto*.


4. The fulfilment of the conditions attached to the permission given above may be made within the specified time period and compliance report should be submitted to the Ministry of AYUSH endorsing a copy to the CCH also. The CCH will verify by means of an inspection that the conditions have been fulfilled and submit a report in this matter to the Ministry of AYUSH for considering the permission matter from the session 2018-19.

5. The College has to comply with the full requirements of HCC (MSR) Regulations, 2013 by December, 2017 for continuing admissions during the subsequent years. CCH shall verify the compliance well in time for considering the admissions during the Academic Year 2018-19 and furnish the recommendations to the Central Government.

6. Please acknowledge the receipt of this letter.



Subject: In compliance to the Order dated in W.P.(C) 3542/2021 filed by Homoeopathic Medical College, Akot Road, Akola vs UOI & Ors at the High Court of Delhi at New Delhi in respect of Homoeopathic Medical College, Akot Road, Akola for Admission matter to UG Courses (Hom.) for session 2020-21 -reg.

Sir/ Madam,

In supersession of the Ministry's earlier Order of even number dated 18.01.2021, I am directed to refer to the provisions prescribed under Section 12C of the Homoeopathy Central Council Act, 1973 and regulations made thereunder and Ministry's policy for the academic year 2020-21, In order to verify the compliance of availability of standards by the College, the Board of Governors to CCH was examined the Part-1 of the proforma of inspection of college and further through inspection of the college on 16.10.2020 of **Homoeopathic Medical College, Akot Road, Akola** and has recommended vide letter no. F.No.15-8/2020-CCH (Visitation matter) /3970 dated 03.12.2020 for not allowing admissions in existing UG Course with 50 seats for the session 2020-21 due to doubtful hospital functionality as visitors has submitted incomplete inspection report and thus, functionality could not proved; absence of guest faculties as attendance & acquittance roll of guest faculties not provided and other deficiencies. The Committee also recommended to apprise the ministry that the college website is not functional and most of the teachers are getting salary less than 10000/-per month."

2. On the basis of examination of the Part-1 submitted by the College and CCH observation, the subject cited college was not found complying the norms, therefore, vide this Ministry's letter dated 07.12.2020, the applicant was given an opportunity of hearing on 23.12.2020 before the designated hearing Committee online to represent

the case. The applicant was appeared before the designated hearing Committee on 23.12.2020 online and made their submission. Based on the submission of the college during hearing, observation of the Hearing Committee and Ministry’s observation, the college was not fulfilling the required criteria as per Homoeopathy Central Council (Minimum Standards Requirement of Homoeopathic Colleges and attached Hospitals) Regulations, 2013. Accordingly, vide this Ministry’s Order of even number dated 18.01.2021, aforesaid college was denied permission for the academic Year 2020-21.

4. However, aforesaid college has filed case in the High Court of Delhi at New Delhi by W.P.(C) 2456/2021 with CM APPL. 7169/2021, which has been heard on 01.03.2021 in the connected matter of the W.P.(C) 2110/2021. The relevant part of the judgment dated 01.03.2021 in W.P. (C) 2110/2021 and connected matters are as under.

"4. Pursuant to these orders, the learned Additional Solicitor General has today submitted a "Status Note". He states that the show cause notices and denial orders assailed in these petitions would be withdrawn, and fresh show cause notices would be issued to the petitioner institutions. A copy of the aforesaid Status Note is taken on record, and the contents thereof are reproduced herein below:

" 3. That, in addition, to obviate further difficulties/ complexities as a result of the Covid-19 pandemic and to allay any/ all reservations (without prejudice to the AYUSH Ministry/CCIM's stand before this Hon'ble Court), the Respondent-Union of India now proposes the following onetime measures by treating the academic year 2020 - 2021 as an exceptional/unprecedented year:

- a. The AYUSH Ministry will grant a conditional approval/permission for the academic year 2020-21 to those institutions which have continuously received permission from Ministry of AYUSH for the preceding 5 academic years, on the basis of the affidavits/ documents already submitted by them. The existing show cause notices and any consequent orders issued against such institutions will stand withdrawn, and no fresh show cause notices will be issued to such institutions.*
- b. The remaining aggrieved institutions would be issued a fresh show cause notice categorically pointing out the deficiencies in detail, along with the documents required for scrutiny and the date of hearing. It is made clear that no new deficiencies would be identified by the AYUSH.*

5. In view of the above, on examination, it has been observed that **Homoeopathic Medical College, Akot Road, Akola** fall under para 4 (3) (b) of the status note, as the the permission of the said petitioner college for the Academic Year 2016-17, 2018-19 and 2019-20 was denied vide Ministry’s denial order no. R.17014/99/2013–EP(H) dated 10.10.2016, R. 17014/99/2013/2018-EP(H) dated 12.09.2018 and R.14014/149/2019-EP(II) dated 15.07.2019 consecutively. The status of the court cases of the A.Y. 2016-17,2018-19 and 2019-20 are as under:

6. Whereas, in compliance to the Court Order dated 01.03.2021 in W.P.(C)2110/2021 & connected matters and in W.P.(C) 2456/2021 with CM APPL. 7169/2021 in the High Court of Delhi at New Delhi, in view of the deficiencies conveyed earlier to the petitioner college vide Ministry's Hearing Notice of even no. dated 07.12.2020, the college was given an opportunity of hearing through Video-conferencing as a principle of natural justice of being heard vide Ministry's Hearing Notice of even no. dated 03.03.2021 to appear before the designated Hearing Committee in the Ministry of AYUSH to present their case for substantiating with respect to short comings already mentioned at earlier hearing notice of even no. dated 07.12.2020. The hearing was conducted on 05.03.2021 via video conferencing. The representative of the college submitted written submissions before the Hearing Committee.

7. Therefore, the said petitioner college has challenged the hearing notice of this Ministry vide letter of even no. dated 03.03.2021 and filed W.P.(C) 3542/2021 at the High Court of Delhi at New Delhi which was heard on 17.03.2021.

8. The relevant part of the judgment dated 17.03.2021 in W.P. (C) 3542/2021 are as under.

19. Further, I am prima facie of the view that, even where the matters remain pending in the High Court, and the High Court has granted permission to the petitioner/institutions to admit students, it is not permissible for the Union to take the view that the institution is not entitled to the benefit of paragraph 3 (a) of the Status Note. Interim orders are passed by the Court on a prima facie finding with regard to the entitlement of the petitioner to the relief sought. In the present case, the denial order for the year 2016-17 has been stayed, pending disposal of the writ petition by the Bombay High Court.

20. In the facts and circumstances aforesaid, I am of the view that the petitioner has made out a prima facie case for interim protection. As far as the questions of balance of convenience and irreparable injury are concerned, I am guided by the observations of the Division Bench in an order dated 04.02.2021 in LPA No. 49/2021 which was passed in the earlier round of proceedings. The Division Bench held that these issues were also in favour of the petitioner/institution in circumstances similar to the present case, and stayed the contrary order passed by this Court on 01.02.2021 in W.P.(C) 1265/2021.

21. For the reasons aforesaid, the petitioner/institution is permitted to participate in the counselling in the State of Maharashtra, subject to the result of its application

*pending with the Union. As the merit list is to be published on 18.03.2021 at 07:00 pm, following which the prospective candidates would take admission in the petitioner/institution, **the Union is directed to dispose of the petitioner's application by 18.03.2021 at 05:00pm and communicate the same to the petitioner within that time.** It is made clear that the present interim order will not create any equities in favour of the petitioner or the prospective candidates admitted by it. The petitioner is directed to inform the prospective candidates, accordingly.*

22. Mr. Kumar also seeks an order directing extension of the cut-off date of 20.03.2021. He submits that several applications for permission remain pending with the Union. Mr. Goyal is directed to seek instructions on this aspect also and assist the Court on the next date of hearing.

23. List on 22.03.2021.

24. Learned counsel for the parties are directed to communicate this order to the parties. A copy of this order will also be placed before the Secretary, Ministry of AYUSH, Government of India.”

9. Therefore, in compliance of the Order dated 17.03.2021 passed by the Hon'ble High Court of Delhi at New Delhi in W.P. (C) 3542/2021, conditional permission of the Central Government is hereby granted to Homoeopathic Medical College, Akot Road, Akola for continuing admissions in BHMS course with 50 seats in UG (BHMS) course for the academic session 2020-21, subject to the final outcome of Writ Petition No. 6264/2016 at Hon'ble Bombay High Court and final outcome with respect to WP(C) No. 3542 at Hon'ble High Court of Delhi.

10. It shall be communicated to the students admitted that admissions made for the A.Y. 2020-21, will be subject to the final outcome with respect to WP(C) No. 3542 at Hon'ble High Court of Delhi and final outcome of the Writ Petition No. 6264/2016 at Hon'ble Bombay High Court.

11. It is further informed that, minimum 15% of undergraduate seats of the permitted intake capacity of BHMS course shall be treated as All India quota. The counselling for seats under All India quota shall be conducted by respective counselling Authority of State / UT Government as designated by the Central Government vide letter F. No. L. 11011/02/2020-E- (1) dated 26.10.2020 for A.Y. 2020-21 and counselling for the remaining 85% seats or as the case may be, shall be conducted by the concerned counselling Authority of that State / UT. **The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the Central Government for All India quota or the students admitted thereunder.**

12. Admissions made in violation of the above conditions will be treated as invalid and action will be initiated under HCC Act & Regulations made thereunder. Discrepancies, if any, may be immediately brought to the notice of CCH and the

Central Government.

13. The College shall comply with the provision for providing EPF and ESI facilities to the teaching, Non-teaching staff of the College/Hospitals and regularly paying the same as per the provisions of Employees' Provident Funds and Miscellaneous Provident Act, 1952 & ESI Act, 1948 and relevant Rules and Regulations.

14. Further, the College shall comply with the procedure to get permanent registration of the Teachers,/ Hospital Clinical Staff/ Consultant in concerned State Boards/ Council where the college/ hospital is located or Central Registration of CCH as per the decision conveyed vide CCH's letter no. 15-1/2018-CCH(3)/18510-18768, dated 16th January, 2019 and decided by the High Court of Delhi in W.P. No. 2369 of 2019, which will be verified by the Council during next visitation while considering the matter for grant of permission for the A.Y. 2021-22.

15. Further, it is informed that the compliance of the all the requirements under the provisions of the HCC Act, 1973 and relevant Regulations made thereunder by the college up to 31.12.2020, will be taken in to consideration for grant / denial of permission for the next academic year 2021-22.

16. In this regard, grievance, if any, may be communicated to the **Grievance Redressal Committee/Appellate Body** which has been constituted as special one-time measure for A.Y. 2020-21 in compliance of Hon'ble High Court of Delhi order dated 01.03.2021 in W.P. (C) 2110/2021 and connected matters, details are available in public domain at <http://main.ayush.gov.in/event/constitution-grievance-redressal-committee-appellate-body-special-one-time-measure-ay-2020-21>.

Sub: Matter related to representation dated 29/12/2021 from Homoeopathic Medical College, Akot Road, Akola-444001 for continuing admission in BHMS course with intake capacity of 50 seats for the academic session 2021-22-reg.

Sir/Madam,

As per the directions of Commission letter of even no. dated 04/02/2022 (**Copy enclosed**) on the subject cited above, Medical Assessment and Rating Board vide its letter F.No.:4-7/2021-22/NCH (MA&RB)/(115-28)/7544-7548 dated 16/02/2022 has conducted a Virtual Hearing for the College. Accordingly, the following observations were made:

1. **Observations of MA&RB letter dated 17/12/2021 mentioned that A. Teaching Faculty: The College has deficiencies as per visitors which are given below:**

i. *Only the affidavit of Dr. S.U. Tiwari is submitted and joining letter is not provided*

Observations of Hearing Committee on 18/02/2022, mentioned that at the time of hearing, Dr. S.U. Tiwari was present and the College has submitted the appointment and joining letter for Dr. SU Tiwari. The deficiencies regarding Point A (i) is been rectified by the College.

Observation of the Commission

Commission examined the documents of Dr. S.U. Tiwari (Professor, Department of Repertory). Temporary approval letter from MUHS dated 19/05/2021 (Date of joining 13/03/2021), appointment letter dated 19/03/1996, experience certificate and found acceptable.

ii. *Dr Pravin Aggarwal (lecturer, Surgery) is appointed since 30/09/2021 in place of Dr. Gulbakshi Subhash Mahkor but certificate of qualification is not submitted. Hence deficiency of Lectuer in the Surgery Department persists.*

Observations of Hearing Committee on 18/02/2022 mentioned that the inspectors referred the documents provided by the College. The Following deficiencies were observed: Though Dr Pravin Agarwal has completed his PG in 2010: (a) PG Degree certificate and registration certificate is not provided; only passing certificate is provided. (b) In the staff list, date of appointment is mentioned as 03/02/2020, but appointment and joining order of Dr Pravin Aggarwal is dated 30/09/2021. The deficiencies regarding Point A (ii) is been rectified partially by the College.

Observation of the Commission

Commission examined the documents and observed that Lecturer in Dept. of Surgery is available now.

iii. *Though the name of Dr. S.U. Tiwari is shown in the Dept. of Repertory, his appointment and joining report has not been submitted. Hence, he cannot be considered as a faculty of Repertory Department.*

Observations of Hearing Committee on 18/02/2022 mentioned that this point is similar to point A (i) and it has been rectified by the College.

Observation of the Commission

Point is discussed under point no 1(i)

2. Observations of MA&RB letter dated 17/12/2021 mentioned that B. Miscellaneous: salary details of teaching and non-teaching staff not submitted. Details of EPF and EPS of teaching staff and non-teaching staff not submitted.

Observations of Hearing Committee on 18/02/2022 mentioned that A detailed discussion regarding the above issue happened in the hearing, the inspectors raised the issue as why the salaries were not paid to the staff. Dr Jai Praksah Jaiswal, Secretary, Homeopathic Medical college and Hospital orally justified that due to Covid situation there were shortage of funds and they have already started paying the regular salaries and arrears to the staff. The inspectors observed and verified all the documents given by the College. Salary details from April 2021 to January 2022 with EPF and EPS were found. A written undertaking from the College management stating all salary arrears will be cleared shortly has been attached. The deficiency regarding point B is been rectified partially by the College (Annexure 3A, B,C, D, E,F; Annexure 4A, B)

Observation of the Commission

Commission examined the documents and observed that the College Management has submitted the declaration for releasing salary within a stipulated time. Moreover, the justification from the College about EPF and EPS records submitted along with appeal is also verified by the hearing Committee.

3. Observations of MA&RB letter dated 17/12/2021 mentioned that Website: website: <http://heshmcakl.in> not updated with relevant information

Observations of Hearing Committee on 18/02/2022 mentioned that the inspectors checked the website and found functioning. The deficiencies regarding website is been rectified by the College.

Observation of the Commission

Commission observed that the website is functional and updated with relevant updates.

Overall observations:


1. The Commission has carefully examined the appeal from Homoeopathic Medical College, Akot Road, Akola before Commission dated 29/12/2021 and directed vide letter dated 04/02/2022 to MA&RB for conducting hearing under natural justice. The report from hearing committee dated 18/02/2022 has carefully examined as per the provisions of the Homoeopathy Central Council (Minimum Standards Requirement of Homeopathic Colleges and attached Hospitals) Regulations, 2013 and observed that the College has rectified the deficiencies pointed out by MA&RB dated 17/12/2021.

1. Teaching Faculty

- The College has submitted 11 Guest Faculty but Guest Faculty are not eligible as yoga, Physiotherapist cannot be considered. Other guest faculty affidavits and previous experience of teaching is not provided.

The college is directed to fulfill all shortfalls within a period of 1 month and compliance report shall be submitted to the board.

After considering the provisions of NCH Act, 2020 and its relevant regulations, permission of the Medical Assessment and Rating Board is granted to **Homoeopathic Medical College, Akot, Akola, Maharashtra 444003 for conducting UG (BHMS) course with intake capacity of 50 seats for the academic year 2022-23.**

3. All admissions in Under Graduate course shall be through NEET only. It is further informed that, minimum 15% of seats of the permitted intake capacity of BHMS course shall be treated as All India Quota. The counseling for seats under All India quota shall be conducted by respective counseling Authority of State / UT Government as designated by the Central Government and counseling for the remaining 85% seats or as the case may be, shall be conducted by the concerned counseling Authority of that State / UT. The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the Central Government for All India quota or the student admitted there under.

- Case records should be maintained with demographic details of the patient such as name, age sex, address, phone number etc.
- Case sheets shall be maintained with complete case analysis and evaluation and repertorisation and made available in medical record room for academic purpose of students.
- Lab investigation report should be maintained properly in case records.
- All follow up attendance should be recorded on the case records.
- Disease diagnosis shall be recorded in all case records as per ICD 11 criteria.

C. Financial details: -


- Form-16 of all faculties shall be submitted from traces portal.
